

## Cookie Policy

### Introduction

Our website uses cookies to distinguish you from other users of our website. This helps us to ensure that you get positive experience when you are browsing it and also allows us to improve our website.

A cookie is a small file of letters and numbers that we store on your browser or on your computer's hard drive providing that you agree to it. Cookies contain information that is placed on your computer's hard drive.

### Types of Cookies We Use

We use the following types of cookies:

- **Strictly necessary cookies.** These are cookies that are essential for the operation of our website. These include, for example, cookies that allow you to log into secure areas of our website, use your shopping cart or e-billing services.
- **Analytical or performance cookies.** These allow us to recognize and count the number of visitors and to see how visitors navigate our website when they are using it. This helps us improve the way our website works, for example by ensuring that users can easily find what they are looking for.
